

## NOTICE

Two (2) copies of construction plans and specifications must be submitted by Applicant. Work may not start until a permit has been issued pursuant to approval of this application. Permits so issued shall not be construed as authority to alter or set aside any building code requirement, nor shall such issuance of a permit prevent the Building Official from therefore requiring correction of errors in plans or in construction, or of violations of building codes or ordinances.

Permit shall become invalid if work is not commenced within six (6) months after issuance, or work authorized by such permit is suspended or abandoned for a period of six (6) months or longer after work has commenced.

Inspections are to be requested as needed during work. A final inspection must be done, and a certificate of occupancy issued before a building or structure is occupied.
