- 5) Contains the following acknowledgement: I am applying for a license on behalf of the potential Licensee and I have actual knowledge of the operation of a Game Room under this permit; I acknowledge that any person operating a Game Room under this permit will do so under my direction and control, and I further acknowledge that I may be held criminally liable for illegal activity associated with the Game Room under this license, including gambling, gambling promotion, or keeping a gambling place under Chapter 47 of the Penal Code; operating an unauthorized Game Room under Article 4.08 of the City's Code of Ordinances; and other applicable penal statutes..

Amusement Redemption Machine License is valid from January 1st through December 31st and must be renewed annually. Applicant may file the renewal application and associated fees for the following calendar year beginning on October 1st.
